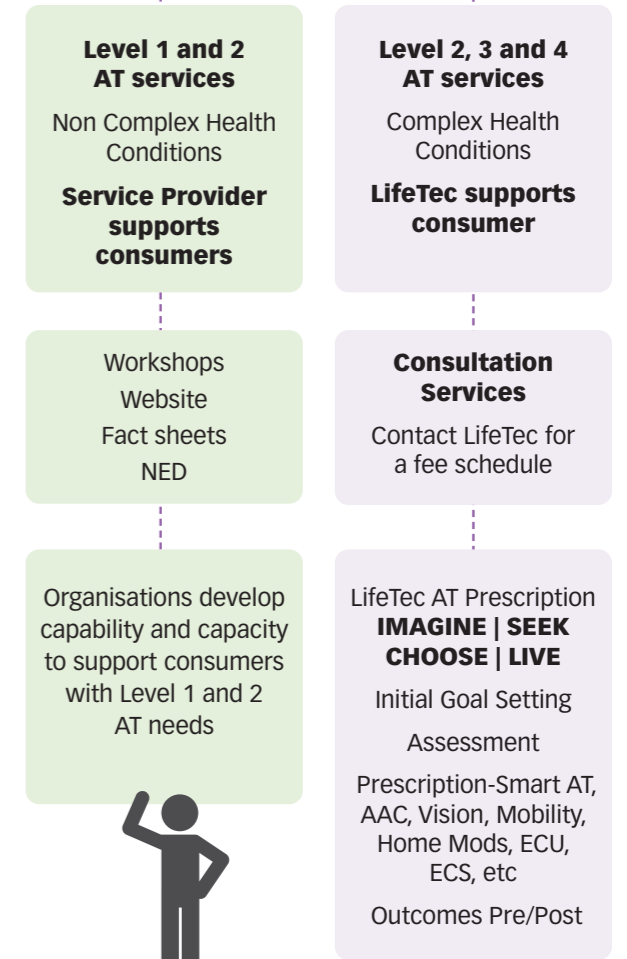


## LIFETEC PARTNERSHIP PATHWAYS
